

# Infosys to Announce First Quarter Results on July 12, 2011

Bangalore, India and Fremont, California – June 29, 2011: Infosys Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its first quarter ending June 30, 2011 on Tuesday, July 12, 2011, Indian Standard Time (IST) (on the night of Monday, July 11, 2011, US Eastern Time (ET)). The results will also be available on Infosys' website www.infosys.com.

Following the release, Infosys' CEO & Managing Director, Mr. S. Gopalakrishnan, Member of the Board & COO, Mr. S.D. Shibulal, and Member of the Board & CFO, Mr. V. Balakrishnan, and other members of the senior management will comment on the company's performance.
