

Infosys Technologies to Announce Second Quarter Results on October 10, 2001

Bangalore, India and Fremont, California, USA. - October 5, 2001 - Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its Second Quarter ended September 30, 2001 on Wednesday, October 10, 2001, Indian Standard Time (IST) (on the night of Tuesday, October 9, 2001, US Eastern Time (ET)). The results will also be available on the Infosys web-site, <a href="https://www.infy.com">www.infy.com</a>.

Following the release, Infosys' Chairman and CEO N. R. Narayana Murthy, Managing Director, President and COO Nandan M. Nilekani, and Director - Finance & Administration and CFO T. V.
