

# Infosys Technologies to Announce First Quarter Results on July 10, 2002

**Bangalore, India and Fremont, California, USA. – July 5, 2002 –** Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its First Quarter ended June 30, 2002 on Wednesday, July 10, 2002, Indian Standard Time (IST) (on the night of Tuesday, July 9, 2002, US Eastern Time (ET)).
